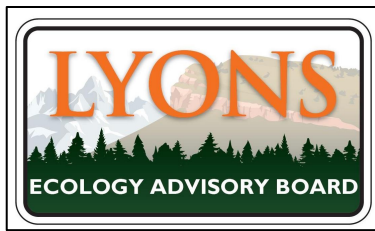

**Watchlist:**

- Lefthand Watershed priority list – Highland diversion minimum flow; Summit Housing bank restoration



- Spirit Hound Expansion – awaiting formal plans for review
- Eastern Corridor (west side) – development here will impact river
- Fire mitigation plans – EAB should have input
- Solar farm – currently on hold (?)
- Andesite mine site and South St. Vrain master plan – BCPOS issue, but EAB should advocate for public access
- Corona Hill Connector Trail – BCPOS; what is EAB role, if any?
- Stormwater master plan – status: EAB should advocate for proper treatment (swales)
- Condition of Lyons Valley River Park – avian flu, ponds’ water quality, flow, bat houses?
