

**TOWN OF LYONS, COLORADO  
ORDINANCE NO. 1086**

**AN ORDINANCE OF THE TOWN OF LYONS AMENDING  
CHAPTER 4, ARTICLE 1, SECTION 70 OF THE LYONS MUNICIPAL CODE  
CONCERNING THE SIGNING OF WARRANTS FOR THE PAYMENTS OF BILLS**

**WHEREAS**, pursuant to C.R.S. § 31-16-105 the Town of Lyons (the "Town") has the authority to make and publish emergency ordinances; and

**WHEREAS**, C.R.S. § 31-20-401 prescribes the way municipalities may sign warrants for the payments of bills; and

**WHEREAS**, the Town previously adopted regulations regarding the signing of warrants of the payment of bill within the Town and codified such regulations in Chapter 4, Article 1, Section 70 of the Lyons Municipal Code ("LMC"); and

**WHEREAS**, The Lyons Board of Trustees desire to amend LMC § 4-1-7-, of the LMC, to bring the LMC in compliance with Colorado state law and Town practice.

**NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF LYONS, BOULDER COUNTY, COLORADO:**

**Section 1. Recitals Incorporated.** The recitals set forth above are hereby incorporated by reference and are adopted as findings and determinations of the Board of Trustees.

**Section 2.** Chapter 4, Article 1, Section 70 of the Lyons Municipal Code is repealed in its entirety and is hereby amended to read:

All warrants or other instruments of payment drawn upon the Town shall be signed by the Mayor. The Mayor may execute, authorize, or cause to be executed all such warrants, funds transfers, or other instruments of payment with an electronic signature in lieu of his or her manual signature upon his or her compliance with State statutes pertaining to electronic signatures.

**Section 3. Severability.** Should any one or more sections or provisions of this Ordinance be judicially determined invalid or unenforceable, such judgment shall not affect, impair or invalidate the remaining provisions of this Ordinance, the intention being that the various sections and provisions are severable.

**Section 4. Repeal.** All other ordinances or resolutions or parts of ordinances or resolutions in conflict with the provisions of this Ordinance are hereby repealed, provided that such repeal shall not repeal any repealer clauses in such ordinances nor revive any ordinance thereby.

**Section 5. Effective Date.** This Ordinance shall become effective thirty (30) days after publication following final passage in accordance with Section 2-2-160 of the Lyons Municipal Code.


**Section 6. Codification Amendments.** The codifier of the Town's Municipal Code, Municipal Code Corporation, is hereby authorized to make such numerical and formatting changes as may be necessary to incorporate the provisions of Section 2 of this Ordinance within

the Lyons Municipal Code.
